In pursuance of Employment Notice No.03/2018 of BSP(H)CL, Shri Raushan Raj is provisionally appointed to the post of Assistant on a probation of two years with effect from his date of joining, subject to verification of Degree, Marks Sheet & other Certificates with the terms and conditions stipulated in offer letter and BSP(H)CL's Employment Notice No. 03/2018:-

1. The monthly consolidated pay will be Rs 15,500/- (Fifteen thousand five hundred) only in the consolidated Pay Band Rs. 15,500 - 29,300 during first year of probation period. No other allowance will be admissible except benefits such as TA and office entitlement etc. will be provided as per Company rules.
2. After successful completion of probation period of first year from the date of appointment, Regular Pay in level-5 (as per 7th PRC) plus other allowances as admissible from time to time from the date of joining will be admissible, subject to conduct and performance remaining satisfactory and achieving the minimum performance targets/indicators. If during probation period, the performance is not found satisfactory, the services may be terminated.
3. As per terms and conditions of security Bond Paper, if he leave the service of the Company before completing two years of probation period, he will be liable to pay a sum of Rs 50,000/- (Fifty Thousand) to the company and he will have to give one month time prior notice for leaving the job or an amount equal to one month's salary in lieu of that.
