Sub: Regarding adoption of vendor with associated GTP/ Drawings for all ongoing/ upcoming projects under BSPTCL.

With reference to the above, this is to inform that all new vendors and its associated GTP/ Drawing approvals is being accorded by P&E department after obtaining approval of Director (Project), BSPTCL for all contracts awarded from Project department of BSPTCL. It has been observed that EPC contractors have to submit for vendors approval/ adoption with all relevant documents for each and every equipments/ items/ materials in each and every contracts. Repeated approvals/adoption for materials of same make in different contract is time consuming which leads to delay in supply of materials for execution of work without any value addition.

Different executing agencies have raised this issue of repetition of process for vendor & GTP adoption, which only results into delay of project execution.

As per provisions of SBD, the list of all approved vendors of different items and their corresponding GTP & Drawings has been uploaded on the website of BSPTCL to avoid repeated approvals of materials.

Approval for adoption of vendors and corresponding GTP & Drawings will not be required at all.

The following steps have to be followed by the EPC Contractors/ Manufacturers for vendor/GTP adoption in the ongoing/ upcoming projects under BSPTCL:

- 1. EPC contractors are directed to select the vendors from the uploaded list and intimate to Project department along with the valid type test, undertaking regarding debarment/ blacklisting and compliance of SBD/ TS/ IS/ IEC.
- 2. Manufacturing clearance will be given by EPC contractors to the vendor for manufacturing of materials based on its approved GTP/ Drawings by BSPTCL complying with the uploaded Technical Specification/ IS/ IEC in the tender.
- 3. It is the sole responsibility of EPC contractors to match the uploaded Technical Specification/ IS/ IEC of equipments/ materials/ items with the approved GTP/ Drawings of vendor prior to manufacturing clearance.
- 4. EPC contractors/ manufacturers shall submit inspection call to BSPTCL complying above instructions.
- 5. Any violation in the Technical Specification of offered materials will lead to rejection of entire lot at the time of inspection.
