Sub: Blacklisting of M/s P. Chandra Reddy & Co. for a period of 03 (Three) years on account of submission of false declaration against NIT No. 58/PR/BSPTCL/2025 concealing the actual fact of debarment from SBPDCL.

Sir,

1. Pertaining to the subject noted above, it is to intimate that BSPTCL had floated a tender vide NIT No. 58/PR/BSPTCL/2025 for the work of construction of 220 KV and 132 KV Double Circuit Transmission Line associated with GSS Mairwa for BSPTCL.
2. While evaluating your bid, this office came to know that M/s P. Chandra Reddy & Co. has been debarred from participating in future tenders till successful completion of work for Construction of 11 KV dedicated feeders and other associated works in Munger Circle of SBPDCL under Mukhyamantri Krishi Vidyut Sambandh Yojna (Phase-II) under state plan against NIT No. 83/PR/BSPTCL/2023 by SBPDCL, vide letter no. 1080 dated 16.04.2025 issued by Chief Engineer, SBPDCL. The debarment order still exists at the time of submission of bid.

3. However, you have submitted an affidavit towards fulfilment of eligibility criteria declaring that the firm has not been blacklisted/banned/debarred/suspended or terminated by Bihar State Holding Company Ltd. or any State Government, Central Government, Semi-Government, Government Undertaking, or Public Sector Undertaking in India in respect of Contracts completed or under execution till date.
4. This establishes that your firm submitted false declaration concealing the actual fact to meet the eligibility criteria against NIT No. 58/PR/BSPTCL/2025, despite having furnished an affidavit affirming the genuineness of all submitted documents.
5. In this regard, you were asked vide this office letter no. 318, dated 30.03.2026 to submit your explanation. Subsequently, you have requested an extension of time for submission of its reply vide letter no. PCRC/BSPTCL/58/01 dated 13.04.2026. The request was considered, and a seven-day extension was granted vide this office Letter No. 370 dated 13.04.2026.
6. Thereafter, you have submitted its reply vide letter no. PCRC/BSPTCL/58/CE-I/PR/2025/01 dated 17.04.2026, which was examined thoroughly; however, the same was found unsatisfactory by the Tender Evaluation Committee.
7. Further, as per instructions of the competent authority, your firm was provided a final opportunity to furnish clarification within seven (07) days vide this office letter no. 417 dated 24.04.2026. Subsequently, you have requested time extension (07 working days) for submission of its reply along with request for personal hearing in regard to the same vide Letter No. PCRC/BSPTCL/58/CE-1/PR/2025/02 dated 30.04.2026.
8. Accordingly, extension of time was granted to the firm as per natural justice and has been directed for personal hearing on 12.05.2026 before Hon'ble Managing Director, BSPTCL at Vidyut Bhawan, Patna vide email dated 30.04.2026.
9. In response, M/s P. Chandra Reddy & Co. appeared for personal hearing on 12.05.2026 before the Hon'ble Managing Director, BSPTCL, at Vidyut Bhawan, Patna and submitted their reply vide letter no. PCRC/BSPTCL/NIT-58/CE-I/PR/2025/03 dated 12.05.2026.
10. In this regard, it is stated that:-
 - (i) The tender conditions unequivocally mandate disclosure of any past or subsisting debarment/ blacklisting imposed by any Government Department, PSU, Power utility or statutory body. Despite this explicit requirement, M/s P. Chandra & Co. have failed to disclose the debarment by SBPDCL and submitted a false declaration concealing the actual fact.
 - (ii) As per clause 3.1 of Section II: INSTRUCTION TO BIDDERS (ITB) wherein it has been stated: "*In case of false declaration, the earnest money deposited by the bidder will be forfeited and appropriate action as decided by the BSPTCL shall be taken*".

- (iii) Procurement Manual of BSP(H)CL uploaded in instant Tender document clearly mandates for Blacklisting of Agency on the ground if “*agency has resorted to corrupt and fraudulent practices including misrepresentation of facts. Providing false certification/ information/ documents; and tampering with documents etc.*”
 - (iv) After thorough investigation, the company has come to decision that your firm have indulged in following prohibited actions which as per clause 3.1 (Eligibility of Bidder) of the Standard Bidding Document (SBD) of BSPTCL and BSP(H)CL Procurement Manual attract the provision of black listing.
 - (v) Moreover, your reply does not contain any new facts or supporting evidence. So, the explanation provided by your firm is found unsatisfactory.
11. As per available record, including your firm's own admission, and as per Clause 3.1 of Section-II (Instruction to Bidders) of SBD of BSPTCL and Procurement Manual of BSP(H)CL (uploaded in instant NIT Tender document), it is conclusively established that your firm has engaged in fraudulent practice by way of misrepresentation and submitted a false declaration concealing the actual fact with the intent to meet the eligibility criteria.
12. Accordingly, in accordance with Clause 3.1 of Section-II (Instruction to Bidders) of SBD of BSPTCL, it has been decided to forfeit the available bid securities, i.e., EMD.
13. Further, as per Procurement Manual of BSP(H)CL uploaded in instant NIT Tender document, it has been decided to blacklist your firm for a period of three (03) years with effect from the date of issuance of this letter.

ORDER

In view of the facts stated above and as per the provisions of the NIT, the decision of BSPTCL is as below:

- (i) **Blacklisting of M/s P. Chandra Reddy & Co., Tirupati from participating in all future tenders of BSPTCL and its subsidiary companies under BSPHCL for a period of three (03) years from the date of issuance of the order.**
- (ii) **Forfeiture of Earnest Money Deposit (EMD) submitted by the firm against NIT No. 58/PR/BSPTCL/2025, in accordance with Clause 3.1 of ITB of the SBD.**
- (iii) **Rejection of the bid submitted by the firm against the said NIT due to submission of false declaration and concealment of facts.**
