In pursuance of Employment Notice No. 03/2024 of BSP(H)CL, following candidates are provisionally appointed to the post of Correspondence Clerk/Store Assistant on a probation of two years with effect from their date of joining, subject to verification of Degree, Marks Sheet & other Certificates with the terms and conditions stipulated in their offer letter and BSP(H)CL's Employment Notice No. 03/2024 :-

1. The monthly consolidated pay will be Rs 9,200/- (Rupees Nine thousand two hundred) only in the consolidated Pay Band Rs. Rs 9,200/- Rs 15,500 during first year of probation period. No other allowance will be admissible except benefits such as TA and other office entitlement etc. will be provided as per Company rules.

2. After successful completion of probation period of first year from the date of appointment, Regular Pay in Level-5 (as per 7th PRC) plus other allowances as admissible time to time from the date of joining will be admissible, subject to conduct and performance remains satisfactory and achieve the minimum performance targets/indicators. If during probation period, the performance is not found satisfactory, then their service may be terminated.

3. As per terms and conditions mentioned in security Bond Paper, if they leave the service of the Company before completing two years of probation period, they will be liable to pay a sum of Rs 50,000/- (Rupees Fifty Thousand) to the company and they will have to give one month prior notice for leaving the job or an amount equal to one month's salary.


