Sub: -To forfeit the BG submitted by M/s Aditya Vidyut Appliances, Thane (Maharashtra) towards security deposit against work order no.24/Tech dated 09.12.16 for the work of repairing, testing & commissioning of 100 MVA, 220/132/33 KV Three phase auto Power Transformer (CGL make bearing sl. no.24447) including materials/spares required for repairing and transportation (To & fro) of 220/132/33 KV GSS Dehri-on-Sone.

NIT no.02/PR/TRZ-Patna/2016 has been floated for the repairing, testing & commissioning of 100 MVA, 220/132/33 KV Three phase auto Power Transformer (CGL make bearing sl. no.24447) including materials/spares required for repairing and transportation (To & fro) of 220/132/33 KV GSS Dehri-on-Sone from this office & work has been awarded to the agency M/s Aditya Vidyut Appliances Ltd., Thane, Maharashtra through W.O no.24/Tech dated 09.12.16 for amounting to Rs.1,87,41,502.00 (Rupees One crore Eighty Seven lakh Forty One thousand Five hundred Two) only.
2. An agreement has also been executed vide agreement no.14/Tech/TRZ-Patna/2016-17 dated 18.01.17 and security deposit in form of BG (BG No.0896517BG0000048, dated 24.01.2017, Guarantee Amount Rs.9,37,075.00 issued by SBI, IFB, Mumbai-400005) has been submitted by the agency.
3. M/s AVAL has requested vide letter no.AVAL/BSPTCL/10603/2016-17/2721 dated 15.02.17 for external inspection & lifting of above mentioned Transformer which has been transported to the work site of M/s AVAL after completion of all formalities.
4. Chief Engineer Transmission (O&M), BSPTCL, Patna had authorized Sri Devendra Choubey, EEE, CRITL, Patna & Sri Shashi Ranjan Kumar, AO Audit, BSPTCL for joint internal inspection on dated 22.03.17 to 26.03.17 as per request made by M/s AVAL vide letter no.AVAL/BSPTCL/10603/J#882/2016-17/2918 dated 10.03.2017.
5. In response of this office letter no.39/Tech dated 18.01.18 M/s AVAL has committed to offer the stage inspection of above said transformer by 08.02.18 vide their letter no. AVAL/BSPTCL/10603/J#882/2017-2018/1584 dated 19.01.2018.
6. M/s AVAL, Thane (MS) did not submitted any offer regarding stage inspection even after several request/reminders issued to M/s Aditya Vidyut vide this office letter no. no.147/Tech dated 31.03.18 & 205/Tech dated 30.04.18.

Subsequently, final notice was served to M/s Aditya Vidyut Appliances Limited, Thane vide this office letter no.314/Tech dated 15.06.18 for (i) Forfeiture/encashment of BG submitted by M/s AVAL against instant work order & (ii) Process for debaring/blacklisting of M/s Aditya Vidyut Appliances Limited, Thane. But still M/s AVAL have not given any response.

ORDER

In view of the consideration of above facts, the Bihar State Power Transmission Company Limited, Patna has decided:-

The security deposit submitted by Aditya Vidyut Appliances, Maharashtra in form of Bank Guarantee vide BG No.0896517BG0000048, dated 24.01.2017, Guarantee Amount Rs.9,37,075.00 issued by SBI, IFB, Mumbai-400005 is hereby forfeited for negligence towards execution of contract agreement.
