Sub: Debarring of M/s SCT Pvt. Ltd. (formerly known as SCT Ltd.), C-15, Industrial Area, Site No. 3, Meerut Road, Ghaziabad (U.P.) from participating in future tenders of BSPTCL till 05.09.2018.

- 1. This is in reference to NIT No.-46/PR/BSPTCL/2016 Package 'A' and 'D' invited on 11.11.2016 by BSPTCL.
- 2. In this instant NIT, the firm participated in the name of M/s SCT Limited, C-15, Industrial Area, Site No. 3, Meerut Road, Ghaziabad (U.P).
- 3. M/s SCT Ltd., Ghaziabad was awarded the work of design, manufacture, testing & supply of 11 nos. of 220 KV Current Transformer, 06 nos. 220 KV Potential Transformer and 75 nos. of 132 KV Potential Transformer under O&M head vide LOI No. 1012, dated 15.05.2017.
- In compliance of said LOI, M/s SCT Ltd., Ghaziabad submitted their acceptance letter vide SCT/2017/144, Dt-23.05.17 bearing name as M/s SCT Pvt. Ltd., Ghaziabad instead of M/s SCT Ltd., Ghaziabad.
- 5. Based on above finding query was made regarding change in name of firm. To this, the firm M/s SCT Pvt. Ltd., Ghaziabad vide their letter SCT/2017/149, dated-23..05.17 and SCT/2017/176, dated 08.06.2017 submitted documents towards change in name of entity from SCT Ltd. to SCT Pvt. Ltd.
- 6. It is to note that as per certificate of incorporation entity name was changed on 21.03.2016 and NIT was invited on 11.11.2016. The PAN and Sales Tax/VAT registration of the company were amended on 07.04.2017, even though information about change in name of firm came after placing LOI dated 15.05.2017 and during submission of unconditional acceptance for LOI.
- 7. The firm M/s SCT Ltd., were requested to submit their reply within a week vide T.O.L No. 1852, dated 07.08.2017 for misrepresenting the facts, misleading the company and concealing it which has hampered the project timeline. But no reply was submitted by the firm. Reminder letter vide T.O.L No. 2022, dated 31.08.2017 was issued to firm.
- 8. The firm vide letter dated 05.09.2017 submitted their reply. The reply was not satisfactory nor could justify the reason for misrepresenting the facts, misleading the company and concealing it.
- 9. Thus there appears sufficient reason to say that firm have deliberately concealed the facts and mislead BSPTCL as the change of company name had taken well before the bidding process. Since all this has knowingly been done which verges on act of fraud. It has consumed time, manpower and adversely affected project timeline of BSPTCL.
- 10. Subsequently, LOI No. 1012, dated 15.05.2017 have been cancelled vide T.O.L. No. 2073, dated 06.09.2017.
