A copy of the same shall be served on to the Chief Engineer (STU), BSPTCL, 4th Floor, Vidyut Bhawan-1, Nehru Marg, Patna - 800021 and proof of serving the same must be enclosed with the filing made to the Secretary, Bihar Electricity Regulatory Commission.

- The objections / suggestions shall be filed in six copies and carry full name and postal address of the person sending the objections. If the objection is filed on behalf of any organization or any class of consumers, it should be so mentioned.
- 6. The Bihar Electricity Regulatory Commission shall conduct public hearings on 01.02.2024 at 11.30 A.M in its Court Room at Patna.
