Sub: Withdrawal of Debarment of M/s Gepdec Infratech Limited & Siemens Limited Consortium from participating in future tender of BSPTCL till satisfactory completion of all works against NIT No. 15/PR/BSPTCL/2019

On account of unsatisfactory progress against NIT No. 15/PR/BSPTCL/2019 for the work of construction of (2x500 MVA+ 2x160 MVA) 400/220/132 KV GIS Sub-Station at Bakhtiyarpur on turnkey basis under State Plan, M/s Gepdec Infratech Limited & Siemens Limited Consortium was debarred vide this Office Order No. 45 dated 29.08.2024 till satisfactory completion of all works against instant NIT.

Subsequent to issuance of the above order, the firm speed up the work and charged the Substation at all voltage level as detailed below:

- ➤ 400 KV Barh (NTPC) Bakhtiyarpur charged on 18.01.2025.
- ➤ 400 KV Bakhtiyarpur- Patna (PGCIL, Gaurichak) charged on 18.01.2025.
- ➤ 400/220 KV, 500 MVA Auto Transformer I & II charged on 06.03.2025.
- ➤ 220/132 KV, 160 MVA Auto Transformer I charged on 10.03.2025.
- ➤ 220 KV Bakhtiyarpur Sheikpura(BGCL) ckt I & II charged on 04.05.2025.
- ➤ 220 KV Bakhtiyarpur Hathidah (BGCL) ckt- II charged on 04.05.2025.
- ➤ 220 KV Bakhtiyarpur Hathidah (BGCL) ckt- I charged on 05.05.2025.
- ➤ 132 KV Bakhtiyarpur Harnaut ckt-I charged on load on 19.03.2025.
- ➤ 132 KV Bakhtiyarpur Harnaut ckt-II charged on load on 11.04.2025.
- ➤ 33 KV SST I & II charged on 07.06.2025.

The firm has completed most of the electrical works and the power flow is being established since charging of GSS. Also, manpower has been deployed by the firm as per scope of work for smooth operation of Substation.

Further, M/s Gepdec Infratech Ltd., vide their letter dated 19.06.2025, has submitted an undertaking to complete all remaining civil works by 15th July 2025 and has requested revocation of the debarment.

After due consideration of the progress made post-debarment and the operational readiness of the GSS, the debarment of M/s Gepdec Infratech Limited & Siemens Limited Consortium is hereby provisionally withdrawn subject to the condition that the balance civil work will be completed by 15th July 2025 as per the undertaking submitted by the firm. If the work could not be completed by 15th July 2025, action for debarment may again be taken immediately as per terms and condition of NIT.

Further, this is to inform that the withdrawal of this debarment shall not absolve M/s Gepdec Infratech Limited & Siemens Limited Consortium from any contractual responsibility as per terms and condition of NIT.
