In pursuance of Employment Notice No.03/2024 of BSP(H)CL, following candidates are provisionally appointed to the post of Correspondence Clerk/ Store Assistant on a probation of two years with effect from their date of joining, subject to verification of Degree, Marks Sheet & other Certificates with the following terms and conditions stipulated in offer letter and BSP(H)CL's Employment Notice No. 03/2024 :-

1. The monthly consolidated pay will be Rs 9,200/- (Nine thousand two hundred) rupees only in the consolidated Pay Band Rs. Rs 9,200- 15,500/- during first year of probation period. No other allowance will be admissible except benefits such as TA and office entitlement etc. will be provided as per Company's rules.
2. After successful completion of probation period of first year from the date of appointment, Regular Pay in level-5 (as per 7th PRC) plus other allowances as admissible from time to time from the date of joining will be admissible, subject to conduct and performance remaining satisfactory and achieving the minimum performance targets/indicators. If during probation period, the performance is not found satisfactory, the services may be terminated.
3. As per terms and conditions of Security Bond Paper, if they leave the service of the Company before completing two years of probation period, they will be liable to pay a sum of Rs 50,000/- (Fifty Thousand) to the company and they will have to give one month prior notice for leaving the job or an amount equal to one month's salary.




