- 1. M/s ECI Engineering & Construction Co. Ltd., {Lead Partner in JV of M/s ECI Engineering & Construction Co. Ltd., Hyderabad and M/s Shanghai Power Transmission & Transformation Engineering company, Shanghai} were awarded the following works. vide NOA No. 134/ADB & 135/ADB both dated 22.06.2012:-

- 4) Construction of 132kV Bettiah- Dhanha DCSS Line
- 5) Construction of LILO of 132KV Pandaul Line at Gangwara
- 6) Construction of LILO of 132KV Sasaram-Kudra line at Pusauli
- 7) Construction of 33KV Dhanaha- Kuchaikot line
- 8) Construction of 33KV Gangwara-Ahilyasthan line .

- 1) Construction of 220KV LILO of D/C of Ara (PG)-Sasaram(PG) line
- 2) Construction of 220KV LILO of D/C of Ara (PG)-Sasaram(PG) line 2nd ckt
- 3) Construction of 220KV D/C Pusauli-Dehri line
- 2. The completion period of entire works was 18 (Eighteen) months from zero date on FIRM price basis. SDOC was 29.05.2014. Most of the work entrusted to the agency is lying pending even after lapse of 48 months and till date only 4 lines have been charged.
- 3. M/s ECI stopped the work after initial start just after award of work till 6 November 2013. A mail was sent in this regard to eci@aciecc.com & venu@eciecc.com. But the response was poor and the agency did not put up the work. During every review meeting, the delayed activity on part of M/s ECI has remained a matter of concern. It was severely requested to deploy adequate gangs for foundation erection and stringing for each line, so that the work could be completed within this working season without further delay by the Agency. Even regular reminders were given to M/s ECI Engineering & Construction Co. Ltd., Hyderabad regarding slow progress of work and to speed up the same. Details are mentioned below:-

ORDER

In view of the facts explained above, the decision of Bihar State Power Transmission Company Ltd is as below:

M/s ECI Engineering & Construction Co. Ltd., Hyderabad is hereby Debarred from participating in future tenders of BSPTCL till satisfactory completion of the ICB No-7/Package-I/BSEB/ADB/2010 & ICB No-8/Package-J/BSEB/ADB/2010.

This order will come into force with immediate effects.
