Bihar State Power Transmission Company Limited (BSPTCL), transmission licensee, hereby gives notice to all stakeholders and general public that it has filed the review petition on BERC Tariff Order in Case No. 20 of 2022 for True-up for FY 2021-22, Annual Performance Review (APR) for FY 2022-23 and determination of Annual Revenue Requirement (ARR) and Tariff Proposal for the FY 2023-24, before the Hon'ble Bihar Electricity Regulatory Commission under Section 62 of Electricity Act, 2003 read with BERC (Multi-Year Transmission Tariff and SLDC Charges) Regulation 2018 and BERC (Multi-Year Transmission Tariff and SLDC Charges) Regulation 2021. The petition has been taken on record by the Hon'ble Commission as Case No. 08 of 2023.
