# INSTRUCTION TO TENDERER (To be attached with Technical & Commercial part)

(Lenderers must read carefully prior to filling and submission of tender documents)

The tender documents and Bill of Quantity can be purchased from the office of Chief Engineer (Civil), BSPTCL, 4<sup>th</sup> floor, Vidyut Bhawan-I, Bailey Road, Patna downloaded from company website. However, the cost of tender forms mentioned in the BOQ to be paid in the form of DD strictly issued till the date of submission of the tender in favour of "Senior Manager (F&A), BSPTCL" payable at Patna from any nationalized/scheduled bank.

In case the tender submitted in downloadable form is not in accompanied with valid DD towards the cost of tender document & EMD, the tender will be summarily rejected.

The tenderer, who will be found indulged in changing/adding or deleting the contents of the tender document will be liable to face necessary action including banning, suspension from business dealing etc.

- Tenderer should submit photocopies of documents duly signed and stamped on each page.
- Demand draft furnished towards the cost of BOQ and EMD shall be in original with technical bid.
- 3. Cost of BOQ will be non-refundable in any case.
- 4. In case of documents for works, required documents, cost of BOQ and Earnest money in shape of Bank draft payable to "Senior Manager (F&A), BSPTCL, Patna" must be submitted along with tender document otherwise, the same shall be rejected summarily.
- 5. On the date of opening, in case of items no. (1) & (2):- only Technical and commercial part would be opened, where as the date of opening of the price part of the successful tenderer it would be intimated later on.
- 6. Cost of EMD & BOQ will be submitted same as mentioned in BOQ.
- 7. Some, items, quantity & rate may be changed and accordingly this will be changed at the time of agreement.
- 8. Technical bid and Price bid shall be in separate envelop.

- 22. Tenderers not meeting qualifying criteria of NIT shall be excluded from consideration for the award of the work.
- 23. Tender should satisfy that the statements as required along with the tender documents are correct and complete in every respect. Any inaccuracy detected later shall vitiate the contract and make the contractor liable to be proceeded against.

# FORCE MEASURES.

- If during the continuance of the contract either of the parties or both are prevented from fulfilling the obligation under the contract due to force measure such as fire, act of nature/ war, riots, political disturbance, military operation or such other circumstances beyond the control of the party/parties, the date of fulfillment of their obligations shall be extended in proportion to the time during which such circumstances prevail.
- ii) The party affected by the force measures as detailed above shall immediately notify in writing the other party of the beginning of such circumstances as also the cessation thereof.
- In case of force measures as detailed above the parties shall immediately meet for consultation and shall work out the measures to be taken.
- The extension of time for completion of work for delay in work attributable to genuine reasons for delay in work on the part of BSPTCL duly recommended by E/I shall be entertained only on the request of contractor. However, no additional cost shall be payable to the contractor for this delays.
- 25. Construction materials which will be used in the work like tarfelt, bricks, sand stone chips, Paints, quality and color of distemper/snowcem and quality of wood will be approved by the Executive Engineer (Civil) E/I of the work and only approved quality is to be used in the work by the Contractor.
- Monthly progress report of the work will be submitted by the contractor to the E/I.

# SPECIAL CONDITION OF CONTRIACT

#### SECURITY MONEY.

The contractor shall have to deposit 10% of the contract value as security deposit, out of which 5% will be submitted as initial security before execution of agreement. In this initial security deposit, 2% of the contract will be submitted as EMD at the time of participation of tender. The balance 5% shall be recovered from the running account bill.

#### 2. IDLE CHARGES.

No charges for idle man, machine, plant and equipment will be allowed to the agency for some reason or the other beyond the control of the department.

#### 3. TAXES

The rates should be quoted including all taxes on all commodities.

#### 4. MAINTENACE PERIOD AND REFUND OF SECURITY:-

Maintenance period/defect liability period will be counted from the date of completion of work. This period will be three (03) months; thereafter security will be refunded after getting a certificate from the Engineer-in-Charge in the prescribed format on the request of contractor that the work has been done as per drawing and specification. The Contractor will have to make arrangement for water both for drinking purpose of the laborers and for construction purpose both at their own cost.

#### 5. EXTRA WORK

The items of work not included in the BOQ shall be termed as extra item. For extra item there should always be a supplementary agreement and rate will be guided by the rate of primary agreement which means the rate approved by the competent authority at the time of primary agreement will be guiding factor for the rate of extra item. It may be lower than that but in any case it shouldn't be more than the rate quoted for the primary agreement.

#### 6. DATE OF COMMENCEMENT.

The date of commencement of work will be considered from the date of work order given to the contractor in writing.

#### MONTHLY PAYMENT.

No interests will be paid in case of delay in any payment.

#### 8. AVAILABLITY OF MATERIALS:-

All materials related to this work i.e. cement, M.S. Rod, M.S. Angle, M.S. Flat, TMTC Fe- 500 rod & Barbed wire etc will be supplied by the Contractor of approved quality by the Engineer-In charge. In case of steel materials it should be from SAIL or TATA or VIZAG.

# 9. ADDITIONAL PERFORMANCE QUARANTEE FOR RATE QUOTED BELOW BOQ RATE-

Additional performance guarantee will be charged at the rate of

- a) 0.25% for every 1% rate quoted below BOQ for rate quoted 0-5 % below BOQ rate.
- b) 0.5% for every 1% rate quoted below BOQ for rate quoted 5-15 % below BOQ rate.
- c) 1.0% for every 1% rate quoted below BOQ for rate quoted 15-20 % below BOQ rate.
- d) 2.0% for every 1% rate quoted below BOQ for rate quoted below 20% of BOQ rate.

#### 10. LIST OF INCOMPLETE WORKS;-

The tenderers shall have to furnish list of unfinished pending work of BSPTCL department with tender in prescribed Performa. (Enclosed)

#### 11. Validity of Tender:-

# ELIGIBILITY CONDITION

# 1.0. QUALIFYING CRITERIA

To qualify for opening of price bid of the contract, each bidder should fulfill the Qualifying/ Eligibility criteria:-

- (a) Bidders must follow the Registration rules of Government of Bihar vide notification no. -6/rule/ -03-04/2002/13589(S)/ Patna dt- 13.12.11 of RCD. Bihar i.e. only class- 04 registered contractors of the concerned district for the work shall be liable for participation in the tendering process for works having value up to 25 lacs.
- (b) DD against tender document (Cost of BOQ).
- (e) EMD against the work (as per BOQ).
- (d) PAN No. (Photocopy of PAN card)
- (e) Labor license must be submitted by successful bidder before execution of agreement.
- (f) GST Registration
- (g) Achieved in annual financial turnover in last three years which is certified by CA (in all classes of civil construction works only) of at least the amount equal to the 50 % (fifty percent) of estimated cost of works for which bid has been invited. The turnover will be indexed at the rate of 8% for a year.
- (h) The Tenderer/ Firm/ Agency should have satisfactorily completed similar nature of works as a prime contractor during the last five years, ending March 2020 as detailed below:-
  - Three similar works each costing not less than 40% (forty percent) of the estimated cost or completed two similar works each costing not less than 60% (sixty percent) of the estimated cost or one similar work costing not less than 80% (eighty percent) of the estimated cost.
- (i) Bidders who meet the minimum qualification criteria will be qualified only if their available bid capacity is equal to or more than the total bid value. The available bid capacity will be calculated as under:

# Accessed available bid capacity is equal to:(A \*M\* N)-B where,

A = Maximum annual turnover in any one year during last 3 years
(Updated to the price level of last year @ 8% a year. i.e Indexed at present value of last year taking 8% as indexing rate) taking into account the completed as well as works in progress.

N= No. of years prescribed for completion of works for which bids are invited. Considering the project completion period of 24 months, N=2 M = 3

B = Value, at the current Price level of existing commitments and ongoing works (Civil, Electrical and other) to be completed during the period of completion of work for which bids are invited (to be submitted by the bidder)

Note: Declaration to be submitted by the bidder indicating the value of Existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed in the declaration.

(j) Even though the bidders meet the above qualifying criteria, they are subjected to be disqualified if they have record of poor performance such as abandoning the works, not properly completing the contract, delays in completion, litigation history or financial failures. Affidavit against the same(No litigation/ debarment/blacklisting) need to be submitted.

Note:- If the tenderer doesn't fulfill the eligibility criteria then he will not be considered in the price bid of tender.
